We at the Police Department hope that you are enjoying the Holiday Season and the unseasonably warm weather!

As 2014 comes to an end it is that time of year again to renew your dog licenses. Current licenses (unless you purchased a two year tag this year) will expire January 31, 2015. You can renew your license at City Hall Monday thru Friday during normal business hours. One year licenses are \$5.00 and two year licenses are \$10.00 for spayed or neutered pets.

As a reminder, though it has been a somewhat open winter so far, please remember to keep your vehicles and trailers off the city streets in accordance with City ordinances to allow for proper plowing by our Public Works Department in the event we get some snowfall. Illegally parked vehicles could result in citations for the owner should they hinder snow removal procedures.

# Public Works Department

How time flies. It seems like yesterday we were gearing up for summer activities and projects and now it is almost Christmas. It seems like we were just sweeping and repairing the streets and now we are sanding and plowing snow. I am keeping my fingers crossed that we don't have another brutal winter like we had last year, so far so good. At a training a few weeks ago there was a National Weather Service meteorologist giving a presentation who was predicting a milder, drier winter. I hope he is right but just in case we have been preparing for the worst. We are better prepared this year with the ability to put more snow plows on the streets. We went into the season last year short handed and without a shop to maintain our equipment but this year we are fully staffed and have a new shop building to work out of. We feel fortunate having been provided the tools necessary to help us to better provide this service and will always strive to do our very best for our citizens.

Since winter is here, I would like to say a few words about one of the most difficult jobs we do and that is plowing and sanding the streets of Colstrip. If possible stay off the streets during street clearing operations and if you need to drive on the streets leave a little early and drive only as fast as conditions allow. Give the snow plows and sander plenty of room and please do not park your vehicles on the streets if you can avoid it. Remember it is against the law to leave trailers and other RVs on the streets during this time of the year. Keeping as many vehicles off the street as possible will help us tremendously making snow removal much safer for everyone. It will also allow us to get the streets cleared more quickly. I would like to thank everyone for their patience and cooperation as the Public Works Department performs this important task.

Also on the street this fall you may have seen our newest piece of equipment, the Duro-Patcher. The Duro-Patcher is a street patching machine that sprays a mixture of emulsion and gravel from the end of a movable boom and can be operated by only 2 guys. So far we have been happy with its performance because it allows us to make cleaner smoother quicker repairs even in cooler weather. It should also help us prolong the life of some of the streets not scheduled for repaving.

We have one construction project underway and another set to begin soon. First is the Backwash Treatment System Project at the Water Treatment Plant. Up until now the dirt that has been removed from the lake water during the filtering process has been returned back to the lake with the backwash water. Around the time the City incorporated, the Montana Department of Environmental Quality (DEQ) applied new discharge limits on this backwash water that the treatment plant could not meet. The City has been out of compliance with this permit ever since. The City has been working with DEQ to find a compromise or alternative which would

## Building/Zoning/Code Enforcement



Winter arrived early this year with accumulated snow and ice on city sidewalks and streets. The accumulated ice under the snow make streets and sidewalks especially slippery.

In Colstrip, the city plows the roads so that citizens can maneuver on the streets within town. The city does not have a snow removal policy because it simply would not be cost effective. That means that when snow storms are forecast, it would prove beneficial to all, if citizens would make sure to park off the streets whenever possible. Snow and garbage removal becomes a problem when plows are required to go around vehicles stored on the city streets bottlenecking traffic and creating unsafe conditions.

Clear sidewalks also make it easier and safer to get around. They are important for everyone who uses sidewalks, but they are especially important for seniors, people with disabilities and children. Snow, ice-covered or blocked sidewalks force people to travel in the street and that is unsafe.

Please remember that after a snowstorm it is the property owner's responsibility to remove accumulated snow and ice from the sidewalk within a reasonable period of time. In addition it is illegal for the snow and ice removed from the sidewalk to be deposited in the streets. Failure to comply may cause the city to remove the snow at the owner's expense. If you do not wish to remove the snow yourself, there may be students or other adults that could use some extra money shoveling snow.

Be considerate of your neighbors. Clear the sidewalks and streets to make our community a safe place for all those who walk or drive in these winter months.



# Colstrip Volunteer Fire Department

Colstrip Volunteer Fire Department provided Fire Prevention Week training again this year for the elementary and preschool kids. This year's theme was "Smoke Alarms Save Lives: Test Yours Every Month". Some of the reminders that were gone over with the students and were supposed to be discussed with parents were:

- Test smoke alarm batteries once a month, replace the batteries once a year and replace smoke alarms every 10 years.
- Escape plans were to be reviewed/made with parents, which included having two ways out of every room, having a meeting place outside and practicing the escape drill twice a year.

Some statistics to think about with this years theme is that almost three of five (60%) reported home fire deaths in the past 7 years have resulted from fires in homes with no smoke alarms or no working smoke alarms and studies have shown that working smoke alarms cut the risk of dying in reported home fires by at least half.

Overall it has been a year with minimal fire calls, so again we would like to thank the Colstrip citizens for being careful and staying safe.

allow us to comply without the expense of a major upgrade to our treatment facility. Many alternatives were explored but the determination was that compliance could not be achieved without an upgrade to the plant. DEQ has mandated the City be in compliance with the permit by the end of February 2015. The compliance plan involves the rehabilitation of the Clarifier Building that has been sitting moth balled for the past 30 years. The project has been awarded to Dick Anderson Construction who began work in early November.

We also have projects planned within our wastewater system. Last year a Wastewater Facilities Master Plan was completed by Kadmas, Lee and Jackson which identified several major deficiencies within our wastewater system. Problems identified at the Wastewater Treatment Plant will involve the construction of a second clarifier and the repair of the existing clarifier. A mechanical bar screen will be added to the headworks making the process more efficient and to protect the downstream processes by the removal of rags, sticks and other foreign material that tends to clog and damage pumps and other machinery. Another part of this project will be the installation of new aerators in the sludge storage lagoon to help eliminate the putrid odors which can emanate from them during certain times of the year. The City is currently seeking a Coal Board Grant to help offset the cost of these repairs.

A second major deficiency identified is the poor shape of three of our existing sewage lift stations. These lift stations were constructed in the early 80s during the Town Site Expansion and are the last of the City's 6 lift stations to receive major repairs. Because these remaining lift stations are in such poor shape it was decided the City proceed now with their repair before a major upset can occur. This project will involve the replacement of the Cherry Street Lift Station and the rehabilitation of the Plum Court and Laramie Circle lift stations. This project has also been awarded to Dick Anderson Construction and should proceed as weather permits.
